The AEMH European Liaison Office

History

1990

Establishment of the European Secretariat, hosted and financial supported by the VLK, German Association of Senior Hospital Physicicans, one of the founder members of the AEMH, in Düsseldorf/ Germany.

2001

Move of the office to Brussels with a progressively decreasing financial support from the VLK. Recruitment of Brigitte Jencik.

2003

End of the financial support from the VLK.

2005

Start of collaboration with FEMS, provision of secretarial services and sharing of office space, with financial contribution paid to AEMH.

2010

Brigitte Jencik going self-employed (end of employer's taxes), and the AEMH Liaison Office going "virtual". Secretarial services paid by FEMS directly to BJ, office space and office facilities paid to AEMH.

Future

2013

Entering the European Domus Medica. AEMH and FEMS will pay office space and facilities directly to the owners.

2014

Recruitment of a new secretary. Self-employment seems difficult and working from a virtual office might not be the best solution for a new recruit.
